



### Competition Suit Rental Agreement

#### **Parties**

#### **Suit Rental Benefits**

The Designer provides the following benefits with rental of a competition suit:

- A. Suit rental for one (1) competition
- B. Free shipping and free return shipping
- C. Free post show cleaning

#### **Payment Terms**

Athlete agrees to pay Designer the rental fee listed below for the rental of a suit for one (1) competition. The rental fee is paid up front at the time the Athlete reserves a suit. Athlete agrees the rental fee is non-refundable.

Bikini Rental Fee = \$250.00  
Wellness Rental Fee = \$300  
Figure/WP Rental Fee = \$350

Athlete agrees to provide a signed credit card authorization (included at the end of this Agreement) to be used by Designer for fees outlined in this Agreement.

#### **Shipping**

Rental suit will ship USPS Priority with signature required the week prior to the Athlete's specified competition.

#### **Exchanges**

If the selected rental suit does not fit, Designer will provide an exchange at no additional cost to Athlete. Exchange suits will be selected by Designer to ensure proper fit. Athlete must provide current measurements to Designer prior to an exchange.

#### **Suit Substitutions**

Designer reserves the right to substitute a suit of Designer's choosing in the event the Athlete's selected suit is unavailable due to late return or damage.

**Rental Returns**

Rental suits are due back at the Designer's address listed above within 7 days after Athlete's competition date listed above on the page 1 of this agreement. Return shipping is included with Athlete's suit rental. Athlete agrees to pay a \$250.00 late fee if the suit is received after 7 days. If the suit is not received within 14 days after Athlete's competition, Athlete agrees to pay the full retail value of the suit which will be billed to the credit card on file with the signed credit card authorization.

**Cleaning**

Designer includes free professional cleaning with suit rental. Athlete agrees to return the rental suit unwashed. Athlete may not wash or dry clean the rental suit. Washed or dry cleaned suits are considered "damaged" and will incur a damage fee.

**Damage**

Athlete may not attempt to repair any damage to the rental suit. If the suit is returned with damage beyond repair as determined by Designer (such as permanent adhesive, permanent alterations, drycleaning damage, etc), Athlete agrees to pay ½ the full retail value of the suit as determined by Designer.

**Cancellation**

All suit rental reservations and payments are non-refundable.

**Policies**

Athlete agrees to abide by the following policies:

- A. Suit rental is provided for the Athlete specified in this Agreement. Athlete may not allow any other individual to wear the rental suit.
- B. Athlete is not permitted to use any permanent adhesive on the inside or outside of the suit. Bikini Bite adhesive is included with suit rental for the Athlete to use on the inside of the suit.
- C. Athlete shall not permanently alter the rental suit in any way.
- D. Athlete shall not wash or dryclean the rental suit.
